
2019 & 2020 Clerk of Year Tree Planting



The scholarship program was established in 1986 for Clerks attending IIMC Institutes. Since the program's inception, more than 1,500 scholarships have been awarded.

For the 2022-2023 year, recipients will receive up to a \$400 CMC or \$400 MMC scholarship reimbursement after completion of the program.

The 2022-2023 Scholarship Application Period is now open. Recipients will be selected in April of 2022 funding programs taking place between June 1, 2022, and May 31, 2023.
