# Sabrena Reinhardt Presents NCAMC Annual Report at IIMC Region III Meeting in St. Louis

St. Louis, MO — During the 2025 IIMC Annual Conference, Sabrena Reinhardt, President of the North Carolina Association of Municipal Clerks (NCAMC), proudly presented the Association's annual report at the Region III meeting. Reinhardt began by highlighting the continued growth of NCAMC, which now boasts more than **650 active members**, a reflection of the strength, dedication, and professionalism of municipal clerks across North Carolina.

She acknowledged the 55 clerks currently enrolled in the **2025 IIMC Clerks Certification Institute Program**, administered by the UNC School of Government. Reinhardt expressed deep appreciation for the School's more than 25 years of service in supporting the development and advancement of municipal clerks.



This spring, NCAMC hosted three in-person **regional one-day training courses** across the state, along with a virtual session. These sessions saw participation from more than 200 clerks, thanks to the outstanding work of the Program and Education Committee and strong collaboration with statewide partners. A key focus of these efforts is to ensure access to training for clerks in smaller towns who may have limited resources—reinforcing the Association's 2024–2025 theme: **"One Person Can Make a Difference."** 


Reinhardt also highlighted the ongoing work of NCAMC's **Publicity Committee**, which is currently redesigning the Association's website. The modern, refreshed site is expected to launch this summer, enhancing communication and access for members statewide.

Looking ahead, NCAMC will host its **Summer Academy Conference** from **August 18–20**, **2025**, **in Cherokee**, **North Carolina**. The location was chosen in part to support tourism in Western North Carolina, a region still rebuilding from the impact of Hurricane Helene. This year's Academy will also feature **a special 50th Anniversary celebration** of NCAMC's founding. Themed around the 1970s, the event will include fun, themed attire and honor Past Presidents and Honorary Members who helped shape the Association's legacy.

The annual Installation Banquet will take place during the Academy, where Reinhardt will deliver her closing remarks as President. Reflecting on her term, she called the role "one of the greatest honors of my professional life," and shared her excitement for the incoming leadership team—President-Elect Linda Christopher and First Vice President Brenda Blanco—whom she praised for their professionalism, integrity, and grace.

Reinhardt concluded her report by encouraging attendees to mark their calendars for the 2026 IIMC Region III Conference, to be held February 17–20 at the Holiday Inn Resort Lumina in Wrightsville Beach, North Carolina. The event promises accessible travel, enriching educational sessions, and meaningful networking.

"Thank you once again for the opportunity to present the North Carolina Association of Municipal Clerks' annual report," Reinhardt said in closing. "It has been a privilege to serve and share our continued story of service, unity, and growth."


